1. Earnest Money and Tender form fees separately of required value shall be submitted in shape of DD of any Nationalised Bank payable in favour of The Executive Engineer, Punjabi University Patiala. Tender fee, Earnest money must be reached on or before dtd 06-02-2019 till 11:00 AM in the Office of the Executive Engineer. Tender will be open in the office of the Executive Engineer.
2. Tender Processing fee should be paid through e- payment (Direct Debit or Internet Banking)
3. The Tender documents shall be uploaded in 2 folders.
 - (i) Folder-A: Shall contain pre qualification documents such as PAN No., GST, Turn Over, Income Tax Return and Black list Self certificate etc uploaded on website.
 - (ii) Folder-B: shall contain financial bid on the prescribed form.
4. In case earnest money is not deposited for not having the required value, the bids will not be considered and rejected straightaway.
5. The folder-B: shall be opened only of those contractors who will be found technically qualified.
6. Corrigendum /Addendum/Corrections, if any will be published in the web site only. Firm shall continue to check the Web site www.tenderwizard.com/PUNJAB
